Appointment of a permanent clerk/treasurer was tabled.

Moved by Eriksen and seconded by Amber Barclay to approve Resolution 24-09 appointing Board Member Utemark as the representative for the Village of Homer for a 1-year term to the Mutual Finance Organization. Members voting Aye: Amber Barclay, Cain, Eriksen and Board Chair Jarod Barclay. Bob Utemark abstained. Motion carried.

Moved by Cain and seconded by Erisen to appoint Amber Barclay as the Fire Department representative on a 1-year term. Members voting Aye: Cain, Eriksen, Utemark and Board Chair Jarod Barclay. Amber Barclay abstained. Motion carried.

Moved by Cain and seconded by Eriksen to approve Resolution 24-10 to appoint Amber Barclay as the Village representative to the Dakota County Public Safety Services Agency. Members voting Aye: Eriksen, Utemark, Cain and Board Chair Jarod Barclay. Amber Barclay abstained. Motion carried.

Moved by Erikson and seconded by Cain to approve the signing of the Year-End Certification of Street Superintendent. All members present voted Aye. Motion carried.

Moved by Cain and seconded by Eriksen to renew the Village's agreement with Siouxland Humane Society. All members present voted Aye. Motion carried.

Moved by Cain and seconded by Utemark to approve the Village's 2 and 10-year water plan. All members present voted Aye. Motion carried.

Moved by Eriksen and seconded by Cain to appoint Board Member Amber Barclay to the 150th Anniversary Committee. Members voting Aye: Eriksen, Utemark, Cain and Board Chair Jarod Barclay. Amber Barclay abstained. Motion carried.

No citizens concerns were raised.

Board Reports - The Board asked Elvin Vavra to salt the streets on Friday in anticipation of the impending freezing rain.

The interim clerk was directed to have an updated rental agreement sent to Mindi Jump for rental of the Village Hall on December 24 and 25.

Maintenance Report - Elvin Vavra reported that a gas line was hit at one of the churches in Homer. He further suggested that letters be sent to people who are 60 days or more delinquent on the utility payments. He also advised that there are issues involving the ability to email utility bills.

Clerk Report – The interim clerk briefly reported on his work to date, and thanked the Village Board for giving him the opportunity to assist the village while the search for a permanent clerk/treasurer continues. His final day in the office will be Thursday, December 19th.
