All members present voted Aye. Motion carried.

Dale Barclay with the Homer Volunteer Fire Department spoke on the number of fire and rescue calls the department responded to in 2024, and the upcoming needs of the department. Dale also raised concerns about Elvin driving Fire and Rescue vehicles on multiple occasions, and Elvins maintenance request forms. Dale also advised that the fire department office door locks have been changed, and they are also adding a locked drawer for additional security of sensitive paperwork. Dale also spoke with other fire departments and found that the Homer village hall and fire department should only need a 60kw generator. Dale is able to purchase a 60kw diesel generator, through the National Forestry, at an estimate of \$500-\$1,000.

Cheryl Ickler with the Homer Volunteer Fire Department advised that the annual AirMed Care Membership renewal cost is \$1,340 this year. It will be added to the August agenda for approval.

Discussion and possible motion to upgrade the water system ACADA was tabled until the August meeting. Elvin will obtain more information on the matter.

There was discussion regarding the purchase of a backup generator for the village office and fire hall. Further action will be taken once Dale Barclay secures a generator.

Discussion and possible motion to upgrade the trail cameras to surveillance cameras at the village maintenance shop/dump and move the trail cameras to the village park was tabled until the NNTC internet is available.

Moved by Cain and seconded by J. Barclay to approve amendment to Article 5 Section 2 505- regarding rabbits and chickens. All members present voted Aye. Motion carried.

Moved by Cain and seconded by Utemark to approve amendment to the parking ordinance on John Street. All members present voted Aye. Motion carried.

Discussion was held regarding the purchase of a sprayer for the lagoons. Elvin is going to research and price a couple of options for the next meeting.

There were no citizen concerns.

Board Report – A local truck driver has concerns of brush/trees blocking the view of oncoming traffic at the intersection of Highway 77 & Blyburg Road and would like the village to trim the trees back for safety. There was also a complaint that the gravel on 2<sup>nd</sup> street is not being bladed all the way to the end of the road.

Maintenance supervisor report- Elvin advised he had nothing to report.

Clerk report- Sam reported that she is still working on reconciliation. She also advised that an individual submitted an application for "as needed" work, and shared the application with the board.

Moved by Utemark and seconded by Eriksen at 6:40PM to move into Executive Session for the protection of the public interest or for the prevention of needless injury to the reputation of an individual. All members present voted Aye. Motion carried.

Moved by Eriksen and seconded by Cain to adjourn at 7:44PM. All members present voted Aye. Motion carried.
